FORM: Authority to Act (Withdraw)

Use this form to authorise a representative or agent to act on behalf of a customer of MI in respect to the following transactions:

- Trade Water: Ability to execute annual water allocation trades on the nominated accounts.
- Order Water: Ability to order water to the nominated property.
- **Financial Information:** Ability to make payment arrangements, order bill reprints and enquire on financial transactions.
- **Change Authority:** Ability to change the authority to act on the account.
- Requests: Ability to submit requests

NOTES

- All account owners are required to sign the form until a nominated person has been given the authority to
 change the authority to act process. However, where there are more than three account owners on the one
 account, then only three of the account owners will be required to sign the form to nominate a person as
 having the authority to act on behalf of that account.
