<ul> <li>You must hold a Water Delivery Contract with MI and not currently be in default under that Contract in order to access this Permit.</li> </ul>	
This Permit is valid until 30 June 2022.	
There is a limit of one Permit per property.	
<ul> <li>This Permit permits a maximum total pumping of 0.5 ML (500,000 Litres).</li> </ul>	
<ul> <li>This Permit allows water to be pumped solely for spray tank filling and harvester washdown.</li> <li>Note: harvester washdown should be conducted at least 15 metres from any MI works and washdown water must not enter any MI works.</li> </ul>	
MI does not guarantee that water will be available in its works in order for you to use this Permit.	
<ul> <li>The Permit Tag must be attached to your pump hose and be visible to enable inspection by MI staff.</li> </ul>	
Misuse or breach of these conditions will result in cancellation of this Permit.	
<ul> <li>These terms and conditions are in addition to your Water Delivery Contract and MI's Rules and you must also use this Permit in accordance with those conditions.</li> </ul>	
Domestic/Hobby Farming purposes are not permitted.
