OR Member and Sole Body Corporate Representative of a corporate shareholder	 The nominee holds voting B class shares in their own name and owns a Landholding registered in the same name as the shares, OR The nominee is the Sole Body Corporate Representative* of, and a shareholder of, a member, and that member: a. holds voting B class shares; and 	
	b. is a landholder; and c. is a company or co-operative.	
Financial	The Constitution and Board Charter requires member directors to be financial to hold the position as a director. This means that all charges have been paid by their due date, or alternatively, the member director has an approved payment arrangement with the Company and is not in breach of the terms of that arrangement.	
No employees	The nominee must not be an employee of the company
